



# BCMEA Scholarship Application

## APPLICATION PROCESS

- Applications must be typed and returned to the BCMEA, postmarked by **June 10, 2024**. Applications must be emailed to [contactbcmea@gmail.com](mailto:contactbcmea@gmail.com) or mailed to BCMEA PO BOX 2413 Oroville, CA 95965.
- A panel of BCMEA Directors and/or official BCMEA ambassadors will choose four (4) scholarship recipients from the application packages received. If selected by the panel, the recipient will be awarded a \$1,000 scholarship that will be distributed directly to the awardee to support their higher educational goals.
- BCMEA scholarship recipients may re-apply each year they meet the qualifications.
- Failure to adhere to any of the requirements may result in disqualification of the application. It is the responsibility of the applicant to ensure that all information is included in one scholarship package. BCMEA will not contact applicants regarding any missing information.
- Please note that only the materials outlined in this application will be accepted for consideration. Supplemental materials will not be used in the selection of scholarship recipients.

## REQUIREMENTS

- ✦ Applicant must be currently attending or enrolled in an accredited two-year or four-year college or university, graduate school, or vocational/technical school. High school seniors may apply with proof of college/technical school acceptance.
- ✦ Applicant must have a cumulative grade point average of at least 2.75 on a four-point scale.
- ✦ Applicant must provide a typed 500 word or less statement detailing their leadership skills and qualities. Applicant must also explain how their career goals will further enhance those skills and qualities. Applicant is encouraged to cite activities and/or personal experiences as part of this response.
- ✦ Applicant must be a current BCMEA member, or the spouse, child, or grandchild of a current BCMEA member.
- ✦ Two letters of recommendation from persons who are not related to the applicant.
- ✦ A copy of the applicant's current transcripts must also be included indicating academic status and major (if enrolled in a college). Transcripts do not need to be official; they can be those obtained from the school's student website.
